Household Hazardous Waste - 5 Gallons  
Used Motor Oil - 5 Gallons  
Gas - 5 Gallons  
Florescent Bulbs - 10 Bulbs

### Landfill Fees

-Residential customers will be charged \$24.00 per ton for the disposal of waste.  
-Commercial customers will be charged \$38.00 per ton for the disposal of waste.  
-Tires will be charged \$210.00 per ton.  
-Special Handling will be charged at \$100.00 per ton.

### Collection Center Fees

Residential/Commercial  
Household Garbage - \$00/\$15 per CY  
Horticultural Trash - \$10/\$15 per CY  
C&D - \$10/\$15 per CY  
(For CY Waste \$5.00 minimum charge)  
Car & Light Truck Tires - \$5.00 per tire,  
Semi Tires \$10.00 per tire, and Off  
Road/Heavy Equip. Tire - \$15.00 per tire  
-Additional \$10 charge for rims.  
-No allowance for C&D or large tree debris  
at Huntington or Interlachen sites.

## Things to know

---

- Driver's License or Photo ID is required for everyone using the Putnam County Central Landfill, Interlachen Collection Center, or Huntington Collection Center.
- Proof of residency is required to dump and must be in the name of the person dumping. Examples of acceptable verification would be current annual tax bill, driver's license or photo ID that lists correct address, utility bill, rental or lease agreement (renters).
- Households that have been assessed the special assessment (located on annual tax bill as Solid Waste Fee) will be allowed to utilize allotments for C&D Debris (3,000 lbs per year) and Residential Yard Trash (5,000 lbs per year). **Central LF ONLY.** After allotment is reached standard charges apply. (See **Tree Debris & Fees** in brochure) **All charges apply @ Huntington & Interlachen facilities.**
- Third Party Haulers – in order for a third party hauler to bring debris into the Landfill and utilize another person's allotment a "Third Party Hauler Form" must be completed **IN ADVANCE** for the hauler to use the other person's allotment. The form must be completed in its entirety, **there are no exceptions to this rule.**

## Tires

- **Residents only** may bring in five (5) car or light truck tires per year at no charge. After the allowed five (5) tires at no charge, standard charges will apply. (See **Fees** in brochure)  
**NOTE: Clean tires only in the tire pit area. No tires on rims.**

## E – Waste (Electronic Waste)

- All E-Waste is to be stacked at the rear Recycling location beyond the scalehouse at the Central Landfill. We do accept TV's and computer monitors, **ONLY the FLAT SCREEN TYPE.** **ONLY** old box style TV's are permitted to be dumped in the Landfill. We now have E-Waste containers at our Huntington & Interlachen facilities also.

## Tree Debris

- **Residential Yard Waste** greater than 4" in diameter and longer than 6' in length is **not** covered in the Assessment; therefore, is charged to the resident (At Central - after annual allotment has been met).
- Only **yard/tree** debris in the **yard/tree** debris pile. If you have bagged leaves you must dump the leaves out of the plastic bags and place the bags in the dumpster on your way out or take the bagged leaves to the landfill.

## Construction & Demolition

### Debris

- C&D is not covered in the Assessment; therefore, is charged to both residential (At Central - after allotment has been met) and commercial loads.

### Metal/Steel

- **ONLY** steel or white goods are permitted in the metal/steel pile. The item being dumped has to be at least 90% metal. If it does not meet this criteria it has to go into the Landfill.
- **Examples of White Goods:** Refrigerator, Freezer, Washer, Dryer, Dishwasher, Hot Water Heater, Microwave, A/C Units.
